The admissions committee weighs heavily the match between the applicant's research interests and the research areas available to students in the school. At the time the student enrolls, the test score must be less than 2 years old. The minimum TOEFL score for admission is 80 (internet-based test). The minimum IELTS score is 6.5.</p>
